

NOTICE OF PUBLIC HEARING

FY 2016 CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT

As set forth in 24 CFR Part 91, the U. S. Department of Housing and Urban Development (HUD) requires state agencies which administer certain HUD formula programs to incorporate their planning and application requirements into one master plan called the Consolidated Plan. In Louisiana, the three state agencies participating in this consolidated planning process and the HUD-funded program(s) administered by each agency include the Division of Administration/Office of Community Development (Small Cities Community Development Block Grant Program), the Louisiana Housing Corporation (HOME Investment Partnerships Program, the Emergency Solutions Grants Program and the National Housing Trust Fund), and the Department of Health and Hospitals/STD/HIV Program (Housing Opportunities for Persons with AIDS Program). A summary of the programs follows.

The **Small Cities Community Development Block Grant Program** provides financial assistance to parishes of less than 200,000 persons and municipalities with a population of less than 50,000 in their efforts to provide a suitable living environment, decent housing, essential community facilities, and expanded economic opportunities. Eligible activities include community infrastructure systems such as water, sewer, and street improvements and economic development assistance in the form of grants and loans. Projects funded under this program must principally benefit persons of low and moderate income, prevent or eliminate slums and blight, or meet urgent community development needs.

The intent of the **National Housing Trust Fund** is to increase and preserve the supply of decent, safe, sanitary, and affordable housing, primarily rental housing, for extremely low-income and very low-income households.

The objectives of the **Home Investment Partnerships Program** are to: expand the supply of decent and affordable housing for low and very low income persons, stabilize the existing, deteriorating owner-occupied and rental housing stock through rehabilitation, provide financial and technical assistance to recipients/subrecipients, and extend and strengthen partnerships among all levels of government and the private sector including for-profit and nonprofit organizations in the production and operation of affordable housing.

The purpose of the **Emergency Solutions Grants Program** is to help local governments and community organizations improve and expand shelter facilities serving homeless individuals and families, meet the cost of operating homeless shelters, provide essential services, and perform homeless prevention activities.

The **Housing Opportunities for Persons with AIDS Program** provides localities with the resources and incentives to devise and implement long-term comprehensive strategies for meeting the housing needs of persons with acquired immuno-deficiency syndrome (AIDS) or related diseases and their families.

The three agencies implementing these programs are preparing their consolidated annual performance and evaluation report for the FY 2016 program year which ended March 31, 2017. The purpose of that document is to report on the progress the State has made in addressing the goals and objectives identified in its Consolidated Plan for FY 2015 – FY 2019 and FY 2016 Consolidated Annual Action Plan.

The State will hold a public hearing to receive comments on the State's performance during the FY 2016 program year. Copies of the Consolidated Annual Performance and Evaluation Report will be available for review and each agency will present a summary of its accomplishments as identified in the report. For those persons who are unable to attend the public hearing, copies of the performance report will be available for review beginning June 8, 2017 at the following locations: the Office of Community Development in Suite 3-150 of the Claiborne Building located at 1201 North Third Street in Baton Rouge; the Louisiana Housing Corporation located at 2415 Quail Drive in Baton Rouge; and the Department of Health and Hospitals, STD/HIV Program Office located at 1450 Poydras St., Suite 2136, New Orleans, LA. The report will also be available on each agency's website. Written comments on the performance report may be submitted beginning June 8, 2017, and will be accepted through June 23, 2017.
